Note:

- 1. 5 Seats of NRI quota per course (in the First Year only) will be filled as per orders of Hon'ble Supreme Court.
- 2. The admission of 10- seats per course (in the First Year only) for eminent sports person's categories will be filled at the college level only.
- 3. The admission for 1- seat per course (in the First Year only) of cultural activity category will be filled at the college level.
- 4. Reserved seats will be filled in accordance with the Punjab Government latest Quota Notification.

IMPORTANT INSTRUCTIONS FOR FILLING THE ONLINE ADMISSION FORM

- 1. The admission form should be filled up by the student in his/her writing. It is compulsory to attach the certified copies of related documents with the admission form. In case not attached, he/she will not be entitled to claim for any category. Incomplete forms and forms with cuttings will be cancelled.
- 2. The admission form, Hostel form and affidavit/undertaking as per annexure, should be duly signed by the Father/Mother/Guardian.
- 3. The claim for reserved category will be given only as filled in the admission form. Any claim, demanded later on, will not be considered.
- 4. The attested copies of the backward classes, scheduled tribes & scheduled castes certificate, duly issued by the S.D.M./ Tehsildar, should be attach with the admission form by the students.
- 5. The applicants, whose results are still awaited, can also fill-up the Admission Form (Provisionally). The Eligibility should be fulfilled at the time of interview.
- 6. The applicant should bring all related original certifies with him/her at the time of interview. It should be compulsory for him/her to submit all original certificates in the office at the time of deposit of admission fees.
- 7. B.P.Ed. 1st (Two years Course) Admission will be jointly conducted by the Prof. Gursewak Singh Govt. Physical Education College, Patiala.

DETAILS OF RESERVED SEATS

Out of total seats in each course:

- 1. 85% seats are reserved for the applicants/students who passed the qualifying examination from the Educational Institutions of Punjab.
- 2. Remaining 15% seats are reserved for those students who passed qualifying examination from other States/U.T., except this out-of-state candidate will not be provided benefit of any other Reservation/category.
 - Note:- a) Reservation Policy against 85% Quota seats of Punjab applicants of SC/ST/OBC/etc. Category shall be as per the latest rules of the Punjab Government.
 - b) The percentage of seats reserved by the Punjab Government can be increased or decreased.
- 3. The reservation of at least one seat and upto 5% seats are reserved in each course for Jammu and Kashmir migrants.

ELIGIBILITY

1) D.P.Ed. (Two Years Course- 4 Semesters):

Candidates with at least 50% marks in the Senior Secondary Examination (+2) or its equivalent are eligible for admission. For those who have participated in State or National or Inter University level in games/sports, the minimum percentage of marks in the Senior Secondary Examination (+2) shall be at least 45%.

2) B.P.Ed. (Four Years Course- 8 Semesters):

Candidates with at least 45% marks in the Senior Secondary Examination (+2) or its equivalent are eligible for admission. For those who have participated in State or National or Inter University level in games/sports, the minimum percentage of marks in the Senior Secondary Examination (+2) shall be at least 40%.

- 3) B.P.Ed. (Two Years Course- 4 Semesters):
 - A) Bachelor's degree in any discipline with 50% marks and having at least participation in the Inter-college/Inter- Zonal/District/School competition in sports and games as recognized by the AIU/IOA/SGFI/Govt. of India. or
 - B) Bachelor's degree in Physical Education with 45% marks. or
 - C) Bachelor's degree in any discipline with 45% marks and studied physical education as compulsory elective subject. or
 - D) Bachelor's degree with 45% marks and having participated in National/Inter University/State competitions or secured 1st, 2nd or 3rd position in Inter College/Inter Zonal/District/School competition in sports and games as recognized by the AIU/IOA/SGFI/Govt. of India. or
 - E) Bachelor's Degree or equivalent degree with secured 1st, 2nd or 3rd position in National/Inter University competition in sports and games as recognized by respective federations/AIU/IOA/SGFI/Govt. of India. or
 - F) Bachelor's Degree or equivalent degree with 45% marks and at least three years of teaching experience (for in- service candidates) as trained physical education teachers/coaches.
- 4) M.P.Ed. (Two Years Course- 4 Semesters):

Candidates who have obtained at least 50% marks in the B.P.Ed. (One Year Course) / B.P.Ed. (Two Years Course) /

B.P. Ed. (Four Years Course) or Bachelor's Degree of Science in Health and Physical Education (B.Sc.) are eligible for admission.

Note:-

- A) The Relaxation of 05% marks will be given at the time of admission towards minimum eligibility/qualifying exam in the favor of SC/ST/OBC categories candidates.
- B) The Relaxation of 10% marks will be given at the time of admission towards minimum eligibility/qualifying exam in the favor of Jammu & Kashmir migrants as per the instruction of UGC wide letter no. D.O.No.1-13/2010 (CPP-II) of dated 20/03/2018.
- C) Candidates who have appeared for the qualifying examination and whose result have not been declared may be provisionally allowed to appear in the Entrance Examination (Physical Strength Test) at their own risk and responsibility but they will become eligible for admission only after they have produced the evidence of having satisfied the above conditions at the time of interview.
- D) The Conditions for Admission can be changed by N.C.T.E. / Punjab Government / Maharaja Bhupinder Singh Punjab Sports University Patiala. The Criteria for preparing the Merit List will be on the basis of Instructions issued by the government as follows:
 - Sports 50%
 - Academics 45%
 - Co-curricular activities -5%

RULES FOR ADMISSION

- 1) The requirements of the Government / Maharaja Bhupinder Singh Punjab Sports University to be received from time to time must be accepted by the candidates.
- 2) Every applicant has to pass the Physical Strength Test in 35 Seconds without any violation. The candidate who failed in the test, their interview will not be taken, Maximum two chances will be given to pass the test, once a foul is committed, then second chance will be given. Details of the physical strength test is hereby given at last page.
 - Note: Physical Strength Test for B.P.Ed. 1st (Two years Course) will be jointly conducted by the Prof. Gursewak Singh Govt. Physical Education College, Patiala. and for M.P.Ed. 1st (Two years Course) Admission will be jointly conducted by the Punjabi University, Patiala.
- 3) The Gradation of Sports certificates must be produce at the time of interview except such sports/Games whose gradation is not done by the Sports Department Punjab but those are approved by All India Inter University and National School Games Federation of India. To avail these benefits, it is necessary to fulfill the following conditions:
 - A) The gradation of such Sports does not done by Sports Department Punjab.
 - B) It is mandatory to bring the below mentioned documents (Sr. No. 1-4) from; a) Director Sports of the University for "All India Inter-University Competitions"; b) President/Secretary of Association for "National Level Competitions"; c) President, Secretary of the District Association for "State Level Competitions" and from the Principal of concerned Institution for "Inter-Colleges sports/Games competitions":-
 - 1) List of team players participated.
 - 2) Name of coach and manager.
 - 3) Year, Date and Place of competition.
 - 4) Candidate must fulfilled all the conditions as required for graduation along with the certificate of related proofs (as above at S.No. 1-4) must be produce to the selection committee at the time of interview, thereafter, these certificates will not be considered in any condition.

Note: The gradation for the certificate issued by the Maharaja Bhupinder Singh Punjab Sports University Patiala is not required.

- 4) All the Candidates who passed the efficiency test, will submit the original certificates of claim for educational qualification and reserve seats before the selection committee at the time of interview. In case, they failed to produce original certificates at the time of Interview, there candidature will be cancelled and he/she will not be entitled to raise any objection for his/her cancellation.
- 5) Admission will be given to those candidates only who submit the Medical Fitness Certificate (As per Annexure III) after successfully cleared the Medication Examination

- conducting by the by Registered Medical Practitioner. If a student is found unfit during the course he/she will not be allowed to continue the course.
- 6) Two Marks per year and maximum ten Marks will be given in the favor of those Physical Education Teachers/ Coaches working in Recognized Institutions only if their Experience Certificates is countersigned by D.E.O./C.E.O.
- 7) The Age of the applicant should be between 17 to 40 years at the time of admission except in service candidates. In service Physical Education Teachers (Male above 35 years/Female above 30 Years) will be exempted from physical efficiency test at the time admission.
- 8) In case any certificate found Fake/incorrect at any time, the admission of the concern student shall be stands cancelled. Due to this misrepresentation, concerned student will not raise any objection for cancellation of his/her admission and required Legal action will be taken against him/her.
- 9) The candidates selected for admission will have to submit the following documents in original in the college office at the time of depositing first fees: -
 - A) Original Degree of Qualifying/required examination required towards Eligibility, if no Degree is yet to be given, then the detailed marks card will be accepted.
 - B) Character Certificate issued by the Head of the last institute attended (for Regular studies) or Character certificate issued by a gazette officer (in case of private students).
 - C) Eligibility certificate (from Punjabi Uni. Patiala)
 - D) Medical Fitness Certificate as per Annexure-II
 - E) In Service Teacher/Coach with N.O.C. from his/her concerned officer/Employer.
 - F) Undertaking Certificate from his/her Father / Guardian as per annexure-III.
- 10. Attested photocopies of the originals certificates should be attached with the admission form. Without these, no claim will be entertained thereafter. Only those original certificates will be seen during interview whose attested Photocopies were already attached with admission form.
- 11. The students who have passed their lower examinations from other Universities / Boards other than Maharaja Bhupinder Singh Punjab Sports University Patiala and Punjab School Education Board, the admission will be given to them only after they getting the Eligibility Certificate from the Registration Branch of Maharaja Bhupinder Singh Punjab Sports University Patiala before admission.
- 12. The decision of Selection committee of Admissions regarding the scrutiny of the academic and sports certificate will be final.
- 13. The names of the candidates, selected for admission, will be displayed on the Notice Board of the College, they will be responsible to deposit the fees in given time, after expiry of that time, the admission will be offered to the waiting list candidates. Waiting list candidate will not be informed separately about this, Students who do not

- deposit the fees in time, their admission rights will have to be abolished. Thereafter, they will not be able to claim for the same.
- 14. Admitted Candidates will be on a one-month's trial, those who found creating indiscipline during this period, their name will be struck-off from the college and fees will be forfeited.
- 15. Any student who creating indiscipline, their names will be struck off. However, on the request of the guilty student, Principal may re-admit the concerned student provided that he/she will deposit his/her fees, fines and re-admission fee (Rs.1000/-).
- 16. Such cases which do not cover according to the instructions given in the college prospectus, The Principal/ Staff Council of the College shall have right to interpret the same and that will be final.
- 17. The Principal and the College Council can refuse admission to any student in the college as per their discretion.
- 18. Any candidate, even if he/she fulfills the all conditions of the admission and eligible for admission according to the merit, can be denied from admission, if he/she has violated the discipline of previous Institute or misbehaved with official during their course or examination. In this regard the decision of admission committee will be final.

19. REFUND:

- A) Refund of tuition fee may be allowed when a student
 - Produces evidence to the satisfaction of the Principal, that he/she has not been able to attend the course at all due to serious illness, provided that the refund is claimed within one month from the admission.
- B) In the event of a student withdrawing before the stating of the course the fee collected from the student, after deduction of the processing fee, shall be refunded subject to the condition that the seat vacated by the student has been filled up.
- C) After admission, if a student attending the course and later vacated his/her seat and if that seat is filled up before the last date of admission, he/she may be refunded the balance of fee, if any, after making proportionate deductions.
- D) No fee shall be refunded to a student who leaves the course after the expiry of the last date of admission.
- 20. Fee of SC/BC/Minorities students as per Post Matric Scheme of Punjab Government.
- 21. Fee concession to Jammu & Kashmir migrants admitted under AICTE norms as per Centre/State Government rules.

COLLEGE RULES

- If a student does not attend the classes upto 15 days from the date of admission, then
 his/her name will be struck off from the college. After clarifying the position to the
 principal within two weeks from the date of his/her name struck-off, he/she can request
 for Re-admission. However, after expiry of two weeks, no further request of readmission will be accepted.
- 2. If the student is remained absent continuously for 10 days during the academic session, then his/her name will be struck off from the college. After clarifying the position to principal within two weeks from the date of his/her name struck-off, he/she can request for Re-admission after paying charges of Rs.1000/- if he/she failed to get re- admitted then he/she will not be re-admitted.
- 3. It is compulsory for Parent/Guardians that they should have knowledge of the record of attendance and performance of internal examinations of their children. In case, student have short of attendance towards 75% required attendance then concerned students will not be allowed to appear in the concerned semester examination.
- 4. To get information from the Principal and concerned teacher about their children education and conduct, It is important for the parents to visit in the College every month on the first and second Saturday between 11:00 a.m. to 1:00 p.m.
- 5. It will be compulsory for every student to read all the notices displayed in the college notice board. Ignorance of rules will not be considered as any excuse.
- 6. No student is allowed to keep any kind of vehicle in college campus/hostel.
- 7. Use of mobile phone in the lectures/activities and college campus, except hostels, is strictly prohibited, in case of violation, the mobile phone will be taken into custody, suitable punishment and fine will be imposed. However Mobile phone will be returned to concerned student only after completion of course.
- 8. The prior permission from the Principal is mandatory to meet the student. No visitor will be allowed to meet any student during theory & practical class in progress.
- The college Management Committee, Principal and staff member will not be responsible
 If any student suffered injuries during the course/test or in the college campus or
 Hostels.
- 10. Ten Rupees (Rs.10/-) fine for absent from Theory Period and Twenty Rupees (Rs.20/-) fine for absent from Practical classes. Rs. 50/- for late comers will be imposed upon defaulters.
- 11. The total fees of each semester should be deposited before the last date, after that late fees will be charged @ of Rs.50/- per day till the fees deposited.
- 12. The fee concession to eminent sports persons and meritorious poor students will be given by the College Management Committee/ Principal/ staff council with the recommendation of three faculty members.

- 13. All kinds of academic and cultural functions will be organized with the prior permission of the Principal, in case of violation or indiscipline, the concerned student(s) will be punished.
- 14. If any student or group of students is found to collect donation or any other goods in the name of college from any student, from other persons or Organization then required action will be taken against guilty student(s).
- 15. If any student violates the discipline of college or misbehave with any other officer/employee, then strict punishment will be given to the concerned student or his name will be struck off from the college.
- 16. The college Management Committee, Principal and staff member will not responsible for any act and conduct of any student outside the college hostel and college campus.
- 17. Ragging is a punishable offense, which is strictly prohibited in the college, the violator will be punished according to the rules.

LEAVE RULES

- 1. In normal circumstances, every student should take leave before the absence, but in case of sudden illness or accident, the leave of such students will be considered.
- Class In-charge can approve maximum three days leave at a time However, the Principal
 can allow leave for more than three days on the recommendations of Class In-charge/
 Hostel Warden/ Superintendent.
- 3. No leave will be approved to any student without the prior consent of the guardian or father.
- 4. It is necessary to send appropriate medical certificate with leave for illness/sickness.
- 5. No Lecture will be given to the students for any kind of leave (casual leave/ medical leave/etc.) except ON DUTY leave.

Note: The Principal is having authority to give Lectures to students who were on duty.

- 6. The Principal and Hostel warden/superintendent are having sole authority to grant leave to students who reside in hostels.
- 7. If a student remains absent without leave or spend more days than his/her approved leaves or who is not reported in the college immediately after the expiry of the leave or duty leave, in that case his/her whole leave shall stands cancelled he/she will be liable to pay fine of Rs. 50/ per day.,

THE RULES FOR COLLEGE EXAMINATIONS

- It is compulsory for all students to sit in the examinations held by the college. Those students who remained absent without permission will be fined Rs. 50/ per subject/paper.
- 2. The exemption can be granted from the examination to a student in case of illness or in any other compelled circumstances, provided that if the student has prior permission from the Principal.
- Leave taken during the exam does not mean that the student will escape from fulfilling the conditions of examination however, later on he/she will be responsible to fulfill the same.
- 4. If any student uses unfair means in the examination or will adopt any other illicit methods, he/she will be punished and fined by the Principal/Examination Committee.

ELIGIBILITY FOR UNIVERSITY EXAMINATION

- 1. It is the responsibility of all the students to fill-up the concerned semester University Examination Form before the due date of without any late fees. If any student failed to fill university examination form, then he/she will be sole responsible.
- 2. To become eligible for university Semester Examination, It will be compulsory for every student to attend at least:
 - (i) 75% lectures out of total theory lectures delivered;
 - (ii) 75% lectures out of total practical lectures delivered.

Note: Due to participation in Sports Competitions or due to any other reasonable cause, if any student attended less lectures in theory and practical then required, the Principal under his/her discretionary powers may give 6% lectures by having reasonable cause.

Part - 1: Theory (PARTS OF COURSE)

Part - 2: Practice of Teaching and Officiating

Part - 3: Skill and Prowess

Note: All the subjects will be taught as per the syllabus based on semester system of Maharaja Bhupinder Singh Punjab Sports University, Patiala. Students can download the syllabus from the website of Punjabi University Patiala.

RULES FOR HOSTEL

- 1. There will separate hostel for Boys and Girls. If required, hostel can be get vacated or closed by giving prior information.
- 2. The Students themselves will run the Mess on the basis of co-operation. In this connection, hostel superintendent/ warden will form a new committee for every month or a contractor is to hired to operate Mess.
- 3. The Superintendent/Warden will appoint the responsible students for his/her help to solve day to day problems of the hostel and detail of rules of hostel will be displayed over the hostel notice board.
- 4. Application for hostels will be given by students along with college admission form.
- 5. The Hostels fees will be deposited along with the college fees. The Detail of expenditure, of mess, should be given to concerned cashier/clerk every month.
- 6. No permission will be given to any visitor to stay in the hostel, who came to meet the boy's /girls students.
- 7. If any student violated the rules or created indiscipline or misbehaved, then he/she can be expelled from the hostel and consequently from the college also.
- 8. No meeting can be held without the prior permission of hostel Superintendent/Warden.
- 9. The opinion of hostel Superintendent/Warden will be taken at the time of issuing the Character Certificate for those student who resided in the hostel.
- 10. Girls will not be allowed to stay with their local guardians/relatives for a day/half-day while their parents had given the authority to them.
- 11. Special rules for Girls –The list and Photographs of visitor of girls should be submitted in the college office immediately after the admission. Hostel warden/superintend may allow Maximum of two guardians (Blood Relation), to meet the girls, with the prior permission of their parents.
- 12. The principal and hostel Superintendent/Warden any time can check the rooms of students.
- 13. The visitors can meet their children only on Sundays or on holidays. No guest will be allowed to meet their children during the theory and practical/activities classes.
- 14. A) Generally Not more than two tubes, one bulb and one fan is allowed in a small room. However, in a big room, not more than two tubes, one bulb and two fans is allowed.
 - B) No student will be allowed to use electrical/electronic equipment, like Iron, trimmer rod, heater, AC, cooler etc. without permission of the principal. However, students with the prior permission of the principal and after paid Installation charges/monthly charges/etc. for the electric/electronic equipment(s) they want to

use, may be allowed to use such electric equipment's. In this regard they will be charged per-student as per-room. Concerned students will be sole responsible for any breakage, maintenance, repair and theft of their own electric/electronic equipment's they used.

- C) If any locked room found with electric/electronic equipment's in running/on condition, then the occupants of that room will be fined Rs.25/- per hours per student.
- 15. If any student cause damage to the college property, then same will be charged from such student(s).
- 16. Student will not be allowed to keep valuables items like gold ornaments or heavy cash in the hostel rooms, in case of theft, the Student will be sole responsible for the same.
- 17. A) No student will not disturb in the work of his roommates by making noise, by singing songs, by whistling, by playing musical instruments, or by any other means.
 - B) No student will be allowed to keep a car, scooter, motor cycle or any other vehicle in the hostel.
 - C) No student will be allowed to stay outside the hostel.
- 18. The use of any drugs/sedatives/intoxicants/smoking items like alcohol, tobacco, narcotics tablets, tobacco in any form etc. will be strictly prohibited in the hostel.
- 19. No student will be allowed to have any weapons in the college hostels.
- 20. The Students will be bound to abide the orders given by the Principal or the hostel Superintendent/Warden from time to time, which will be helpful in maintaining student discipline.
- 21. After completion of a academic session all the students will return/deposit all equipment's and articles of their rooms/hostel in good condition to the Hostel Superintendent/Warden. In case of any damage found, then same will be recovered from the concerned room occupants or will be deducted from their security amount. If needed, the Character certificates of the concerned students will stop.
- 22. The Principal will compulsory conduct checking of Boys and girls hostels once in a month.
- 23. After completion of an academic session, the counting of all the goods/items of hostel will be done by the concerned hostel Superintendent/Warden.
- 24. The Principal will publish detailed duties and responsibilities of the Superintendent/Warden of both Hostels. One copy of the same will be displayed on the notice board of the hostels and all hostlers will abide by them.
- 25. Ragging is a punishable offense, which is strictly prohibited in the college, the violator will be punished according to the rules.

WOMAN EMPOWERMENT CELL

The Women Empowerment Cell has been established in the college for empowering the women and to get aware about her rights among the students, in which declamation contest isbeing organized from time to time.

COLLEGE MAGAZINE

The College Magazine 'Parwaaz' is printed, Student are appointed as Editor by the Principal on the recommendations of the professor in charges. An opportunity is provided to students to publish their articles in the College Magazine, by which their talent can be exposed.

LIBRARY

Duration to keep the Books:

- 2. Students:
 - (A) The books having mark 'R' to be provide only for library reading room.
 - (B) Reserved Books for Course Only for One Night
 - (C) other books 10 Days

Note: -Books kept for more time than fixed days, the fine will be charged as follow:

- (A) Reserved Books for Course Rs.10/- Per Day
- (B) Other books Rs.10/- Per Day

If any book lost from any member/student, then he/she will be entitled to return back with new book of same author, title and language or will have to pay double the MRP of the book. Such books, which are not under demand, the same can be reissued. But its authority is with the librarians, who can use their discretionary power. If needed, the Librarian can call to return the book at any time. Reference books and Rare books will not be issued to anyone without permission by the Principal or Librarian, but in case of loss of rare book, ten times more will be charged.

After admission and in the beginning of an academic session, it is mandatory for a student to collect their Identity Card and Readers ticket. After that a suitable fine will be charged from them on per day basis. This card cannot be swapped with any other member. This card is required at the time to issue the books.

It is important to keep this card safely. It is the responsibility of the students towards books issued and entered in the card.

In case any student lost his Library Identity card, duplicate Identity card can be obtained from the library by depositing Rs.100/- in the office along with the copy of police F.I.R./D.D.R.

Note: At the time of getting No Dues clearance from Library, it is mandatory for every student to deposit their Identity Card and Readers Ticket at the Library.
