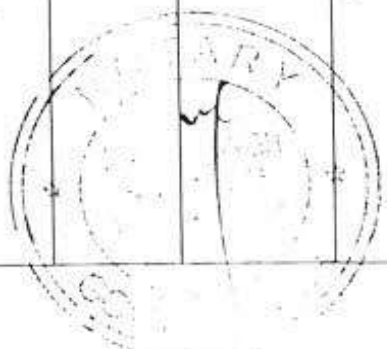

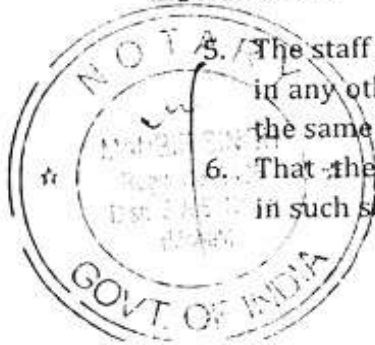

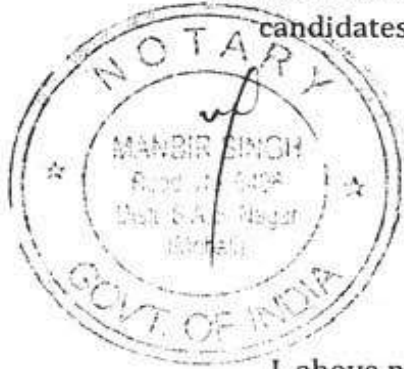

10. The information about staff has been verified from the original records submitted by the candidates and found correct.






