the properties and assets of the National Education Society (Regd) Kharar
for creating property of the Trust and the Trustees have acknowledged
the receipt of the same with the condition that all the existing liabilities
as on the day of creating the Trust of the Creator henceforth shall be
discharged by the Trust and the Creator shall have no connection with the
existing liabilities and the assets. Now this Deed witnessed as follows:-

1. NAME

The name of the Trust shall be "SHAHEED KANSHI RAM
EDUCATIONAL TRUST".

2. AIMS AND OBJECTS

(i) to establish and to take over existing Institutions such as
Schools, Colleges, Literacy Homes, Libraries, Reading Rooms,
Boarding Houses, Rest Houses, Play-Fields and Stadiums,
Art Galleries, Theatres, Museums, Hospitals, Maternity and
Nursing Homes etc at KHARAR and elsewhere in India with a view :-

to provide instructions in (a) Punjabi, Hindi, English
and all other Indian and Foreign languages; (b) Humanities;
(c) Commerce; (d) Science, both theoretical and applied
including Medicine, Engineering etc and (e) other
subjects of study.

The Chairman shall have also powers to remove the said Secretary of the Trust as and when he deems it proper for the proper functioning of the affairs of the Trust. The Chairman shall also fix honorarium or salary or any other allowance for the Secretary of the Trust.

5. POWERS AND FUNCTIONING OF THE BOARD OF TRUSTEES.

- (a) The Trustees shall have full authority to utilize properties of the Trust for furtherance of the aims and

(ii) depositing as Fixed Deposits in Banks.
- (c) to raise loans (short or long terms) from Banks or other sources against its fixed deposits, landed property and other movable and immovable assets for extension of the Trust's work.
- (d) to sell any movable or immovable property of the Trust for the ~~purpose~~ purpose of meeting liabilities of the Trust or any of its Institutions or other urgent requirements of the Trust.
- (e) to administer and direct the affairs of the Trust and all the Institutions through the Chairman of the Trust.
- (f) to co-opt any one as Trustee in the event of a vacancy caused in the Board of Trustees on account of deaths/resignations.
- (g) In case of resignation or death of the Chairman or the Vice-Chairman, the Board of Trustees is empowered to elect from amongst themselves, the Chairman or Vice-Chairman, as the case may be, by a majority vote.

5. POWERS AND FUNCTIONING OF THE CHAIRMAN

- (a) The Chairman shall have absolute powers to manage the affairs of the Trust and its various existing Institutions or Institutions which may be created in future on behalf of the Trust, directly or by appointing Managers or creating Managing Committees. The Chairman shall also have absolute powers to reconstitute the Managing Committees and remove Managers appointed by him for the Institutions as and when he deems it proper for effective functioning or in larger interests of the Trust.
- (b) to preside over the meetings of the Trust and take votes, if necessary, and declare results of the voting, to determine the order in which several proposals shall be laid before the Trust and to supervise and conduct the business of the meetings of the Trust.
- (c) The Chairman shall be provided with all office facilities, befitting to his status, at his residence and shall also be

provided with free transport and other expenditure incurred by him in the performance of his general duties towards furtherance of the aims and objects of the Trust inside the State of Punjab and other parts of the Country, or be paid any honorarium as decided by the Trustees.

- (d) to sanction expenditure to meet requirements of the Trust and its various Institutions.
- (e) The Chairman shall have all other powers except those allotted to the Board of Trustees, according to the By-laws of the Trust.
- (f) The Chairman shall operate all Bank A/Cs of the Trust singly and the Vice-Chairman and the Secretary jointly.

POWERS AND FUNCTIONING OF THE VICE- CHAIRMAN

The Vice-Chairman shall exercise all the powers and functioning of the Chairman in case of the Chairman's permanent absence or in case all or any powers of the Chairman are delegated to him by a written authorisation of the Chairman for any specific period.

FUNCTIONING OF THE SECRETARY

- (a) to call general or special meetings of the Trust and to issue agenda for the same under orders of the Chairman.
- (b) to record the proceedings of the meetings of the Trust.
- (c) to issue receipts for all the sums received for the Trust, and deposit the same in any Bank as per directions of the Chairman.
- (d) to draw amounts from Banks by means of Cheques under orders of the Chairman or as decided by resolutions of the Board of Trustees.
- (e) to keep proper record of receipts and disbursements and maintain Cash Books and Ledgers, other accountable documents and books, as may be prescribed by the Chairman or the Board of Trustees from time to time.
- (f) to keep and maintain necessary records and registers in connection with the accounts and property etc of the Trust.
- (g) to prepare annual Income & Expenditure statements and Balance Sheets of the Trust and get them audited by the Chartered Accountants.

9. AMENDMENTS

The terms of the Trust as incorporated in this Deed by the Creator of the Trust shall not be amended, changed or modified except by a unanimous resolution of the existing Board of Trustees. The aims and objects of the Trust which authorises the Trust for the transfer or application at any time of whole or any part of the Income or Assets of the Trust for any other purposes other than the charitable purposes as provided in the aims and objects, shall not be amended, changed, altered or modified at all.

- (f) The Chairman shall operate all Bank A/Cs of the Trust singly and the Vice-Chairman and the Secretary jointly.

7. POWERS AND FUNCTIONING OF THE VICE-CHAIRMAN

The Vice-Chairman shall exercise all the powers and functioning of the Chairman in case of the Chairman's permanent absence or in case all or any powers of the Chairman are delegated to him by a written authorisation of the Chairman for any specific period.

8. FUNCTIONS OF THE SECRETARY

- (a) to call general or special meetings of the Trust and to issue agenda for the same under orders of the Chairman.
- (b) to record the proceedings of the meetings of the Trust.
- (c) to issue receipts for all the sums received for the Trust, and deposit the same in any Bank as per directions of the Chairman.
- (d) to draw amounts from Banks by means of Cheques under orders of the Chairman or as decided by resolutions of the Bank Board of Trustees.
- (e) to keep proper record of receipts and disbursements and maintain Cash Books and Ledgers, other accountable documents and books, as may be prescribed by the Chairman or the Board of Trustees from time to time.
- (f) to keep and maintain necessary records and registers in connection with the accounts and property etc of the Trust.
- (g) to prepare annual Income & Expenditure statements and Balance Sheets of the Trust and get them audited by the Chartered Accountants.

9. AMENDMENTS

The terms of the Trust as incorporated in this Deed by the Creator of the Trust shall not be amended, changed or modified except by a unanimous resolution of the existing Board of Trustees. The aims and objects of the Trust which authorizes the Trust for the transfer or application at any time of whole or any part of the Income or Assets of the Trust for any other purposes other than the charitable purposes as provided in the aims and objects, shall not be amended, changed, altered or modified at all."

After giving full consideration to the implications of the proposal of the Executive Committee for creation of the Trust as well as considering the proposed draft of the Aims and objects and Terms of the said Trust, the members present in the meeting -

- (i) unanimously resolved that the Trust known as "SHAHEED KANSHI RAM EDUCATIONAL TRUST" be created for the purposes as mentioned in the said Draft Trust Deed.
- (ii) Further the proposal regarding the aims and objects and Terms of the proposed "SHAHEED KANSHI RAM EDUCATIONAL TRUST", ~~xxx~~ is also unanimously adopted in-toto.
- (iii) The Members further empower and authorize Shri Balwinder Singh, Member of the Executive Committee of the National Education Society (Regd) Khurram to take all the necessary steps for getting the Trust created and registered within a period of three months with effect from today i.e. 14th May 1978.
