RECOGNITION ORDER

WHEREAS in terms of section 14(1)/15(1) of the NCTE Act, 1993, the institutions had submitted applications to the Northern Regional Committee of NCTE for grant of recognition for Teacher Education Courses.

- AND WHEREAS on scrutiny/perusal, veracity of the facts & figures as per the application submitted by these institutions, the documents attached therewith, the affidavit and the input received from the visiting team in the form of visiting team report including videography and also the reply submitted by the institution against letter of intent under clause 7(13) of the NCTE Regulations, 2014 (earlier 7(9) of the NCTE Regulations, 2009), the Northern Regional Committee in its 250th Meeting of the NRC (Part-5, 24.02.2016) is satisfied that the institution/society fulfils the requirements under the provisions of NCTE Act, Rules and relevant Regulations including the Norms and Standards for the concerned Teacher Education Programme such as instructional facilities, infrastructural facilities, library, accommodation, financial resources, laboratory, etc. for running the programme and has selected/appointed duly qualified teaching staff as per NCTE norms.

- Eight years teaching experience out of which five years experience in an institute/college/department of physical education.
- Any other stipulation prescribed by the UGC/affiliating body/State Govt. From time to time for the (iv) positions of principal shall be mandatory.

B. Associate Professor

- M.P.Ed. degree or its equivalent with at least 55% marks or its equivalent grade i.e. in the seven point scale of letter grades O,A,B,C,D,E,F, as per UGC norms.
- A minimum of eight years of experience of teaching and/or research in an academic /research position equivalent to that of Assistant Professor in a University, college or accredited research institutions /industry (ii) excluding the period of PHD research with evidence of published work and a minimum of 5 publications as books and / or research /policy papers.

Note :- any other stipulation prescribed by UGC /affiliating body /state govt from time to time for the position of associate professors shall be mandatory.

Assistant Professor

M.P.Ed. degree or its equivalent with 55% marks or its equivalent grade i.e. B in the seven point scale of letter grades O,A,B,C,D,E,F as per UGC norms.

Note :- any other stipulation prescribed by UGC /affiliating body /state govt from time to time for the position of Assistant professor shall be mandatory.

10. Helpers/ Attendants

The terms and conditions of service of teaching and non-teaching staff including selection procedure, pay scales, age of superannuation and other benefits shall be as per-the policy of the State Government/Affiliating body.

As per decision of NRC taken in 240th Meeting of the NRC held on 20th to 22nd July 2015, the institution shall ensure that it has become a composite institution before the commencement of the academic session 2016-17.

The institutions shall adhere to the fulfillment of the provisions of the NCTE Regulations, 2014 and ensure the following before commencement of the session:-

- (a) The institution which have submitted reply to Letter of Intent and appointed staff as per provisions of the NCTE Regulations, 2009 with the approval of the affiliating body shall be required to modify/replace the required faculty as per provisions of the NCTE Regulations, 2014. The institution shall be required to submit the compliance report before the commencement of the session 2015-16.
- (b) The institutions whose applications were pending with the Regional offices before 1.12.2014 (the notification of Regulations, 2014), shall be considered for recognition as standalone institutions but move gradually to become a composite institution but not later than 2016-17.
- 4. Further, the recognition is subject to fulfilment of all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/Body, the State Government etc. As applicable. The affiliating body (University/State Govt.) shall also required to verify the authenticity of the land & building documents as well as appointment of requisite teaching knon-teaching staff as per provisions of the NCTE Regulations, 2014 by the concerned institution is a superior of the NCTE regulations. institution before grant of affiliation to an institution.
- The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along the statement of annual accounts duly audited by a Chartered Accountant.
- The institution shall maintain & update its Web-site as per provisions of NCTE Regulations and always display following as mandatory disclosure:-
 - Copy of the Application Form
 - Land and Building Particulars (ii)
 - Staff Profile
 - Recognition letter (iv)
 - Information for having fulfilled the norms & standard and other required conditions.
- In case if the land is in the name of the Society/trust, the land is to be transferred within six months in the name of the institution, failing which action shall be initiated to withdraw the recognition. It shall be essential on the part of the

- institution concerned to get the needful done in this regard and intimate about the same to the respective Regional Committee along with the new land documents within the stipulated time.

 8. If the institution contravenes any of the above conditions or the provisions of the NCTE Act, Rules, Regulations and Orders made or issued there under, the Regional Committee shall withdraw the recognition as under the provisions of Section 17(1) of the NCTE Act.
- 9. Further, if the institution is not satisfied with the order, it may prefer an appeal under sections 18 of NCTE Act, 1993 in the "online mode" available on NCTE's website www.ncte.india.org within 60 days from the date of this order. The guidelines for filing appeal may be seen on NCTE's website.
